Penalty Fees		
- Late Payment:	Up to \$27.00 or the amount of the required minimum payment, whichever is less, if you are one (1) or more days late in making a payment. In the event you fail to make a payment on time in any of the six (6) billing cycles following the initial violation, you will be charged up to \$38.00 or the amount of the required minimum payment, whichever is less.	
- Over-the-Credit Limit: - Returned Payment:	None Up to \$27.00 the first time your payment is returned for any reason within the following 6 billing cycles, you will be charged up to \$38.00 for each returned payment.	

How We Will Calculate Your Balance: We use a method called "average daily balance (including new purchases)."

Minimum Payment Requirement: \$25.00 or 2% of balance plus the full amount of any balance in excess of your credit limit.
